- PREHEARING CONFERENCE: The Commission held a prehearing conference in this matter in Olympia, Washington, on Tuesday, February 27, 2001. The prehearing conference was held before Administrative Law Judges Marjorie R. Schaer and William E. Hendricks.
- PARTIES: Robin D.R. Carper, Spokane, represents Robin D.R. Carper, d/b/a Rob's Demolition (Rob's Demolition). James Sells, attorney, Silverdale, represents the Washington Refuse and Recycling Association. Polly L. McNeill, attorney, Seattle, represents Waste Management of Washington. Jonathan C. Thompson, Assistant Attorney General, represents the staff of the Washington Utilities and Transportation Commission.
- ISSUES: The parties agree that the petition presents two issues. The first issue is whether a certificate is required for the service that Rob's Demolition proposes. The issue presents two questions: (a) is the service for which Rob's Demolition requests authority incidental to its primary business; and (b) is the service it proposes recycling, rather than waste hauling.
- Second, if a certificate is required: (a) does the public convenience and necessity require that Rob's Demolition be granted authority to provide the services; and (b) is the service that the existing certificate holder provides satisfactory to the Commission.
- NOTICE IS HEREBY GIVEN that, in accordance with WAC 480-09-700(1)(a), the Commission has determined that good cause exists for this matter to be heard upon a shortened notice.
- NOTICE IS FURTHER GIVEN that a hearing in this matter will be held on Tuesday, March 20, 2001, beginning at 9:30 a.m., at Eastern Washington University, 705 West 1st Avenue, Room 208, Spokane, Washington.
