On May 16, 2003, Mr. John Ness, d/b/a Jantech, filed Application No. D-79171 in Docket TC-030782 for a new auto transportation company certificate of public convenience and necessity to provide passenger service between San Juan Island and Seattle-Tacoma International Airport via the Washington State Ferry Service to Anacortes. Closed-Door service between San Juan Island and the Seattle-Tacoma International Airport. Note: All passengers must have Seattle-Tacoma International Airport as an origin or destination.

Application No. D-79171 appeared on the Commission's June 9, 2003, application docket. No one filed a protest, petition to intervene, or application for overlapping authority during the docket and protest period. No existing auto transportation company certificate of public convenience and necessity appears to include authority to provide the proposed service in the territory requested.

The applicant filed a complete application and has no outstanding penalties, fines, administrative, or compliance actions pending before the commission.

Under the provisions of RCW 81.68.040 the Commission may grant an application with or without hearing when there is no existing certificate holder serving the requested territory. D79171 is an uncontested application for authority to provide passenger transportation services as an auto transportation company in an area that no existing certificate holder appears to have the authority to serve and therefore no hearing is required.

Since no hearing is required in this application and there are no issues that suggest staff should ask the Commission to set the application for hearing, I recommend this application be forwarded to Licensing Staff for processing and preparation of an order granting the application without hearing.

The applicant must file verified statements supporting the need for service in the requested territory.

The company's tariff and schedule need to be finalized and a copy of the final order granting the application and a copy of the certificate is required to update the tariff records.

Since this application was filed Mr. Ness has changed his business structure from a sole proprietor to a limited liability company of which Mr. Ness is the only member. The carrier records should be updated to reflect that recent change of business structure and the certificate should be issued to the LLC. *PK*
