PROTEST OF HAROLD LeMAY ENTERPRISES, INC.

COMES now Protestant, HAROLD LeMAY ENTERPRISES, INC., by and through its attorney, JAMES K. SELLS, and protests those portions of the above-referenced application which seek service in areas currently served by Protestant pursuant to WUTC Certificate G-98, and those areas sought to be served by Protestant pursuant to Solid Waste Application TG-040221/GA079251 filed with the Commission February 11, 2004.

Protestant alleges and prays as follows:

- 1) Harold LeMay Enterprises, Inc., d/b/a City Sanitary Co., EGH Disposal, Harbor Disposal Co., Joe's Refuse Service, Lakewood Refuse Service, Pacific Disposal, Pierce County Refuse, Rural Garbage Service, White Pass Garbage Co., and Butlers Cove Refuse is the holder of WUTC Certificate G-98 which provides for service in Pierce County, Grays Harbor County, Lewis County, Mason County and Thurston County. A true copy of the certificate is attached hereto.
- Protestant has applied additional for authority, specifically biomedical waste in King, Pacific, Kitsap, Cowlitz, Clark Wahkiakum, and Skamania Counties. That application predates the application of Applicant herein.

- 3) Protestant fit, willing and is able to biomedical waste service within its current territory and is doing so to the satisfaction of the Commission. Protestant also is fit, willing and able to provide the service sought in its Application TG040221/GA079251 to the satisfaction the Commission.
- 4) Protestant has invested significant funds to serve customers in its territory, and a grant of additional overlapping authority would be detrimental to those investments and contrary to the public interest. The service sought in this application is not required by the public convenience and necessity.
- 5) Applicant herein cannot establish its fitness to conduct operations nor its compliance with the laws and regulations applicable to solid waste collection.
- Protestant will appear at any hearing in this matter and estimates it would present 10 to 15 witnesses at one-half to one hour each.
- An amendment to the application excluding those areas served by Protestant pursuant to WUTC certificate G-98, and those areas sought by Protestant in Application TG-040221/GA079251 would satisfy Protestant's interests herein, if and amendment were offered and approved, this Protest would be withdrawn.

WHEREFORE, Protestant prays the above application be denied.
