The complainants are customers in the service area of Respondent. The respondent is a privately-owned water system purchasing water from the City of Monroe and operating in Snohomish County. The complainants allege the respondent is charging unfair and unreasonable water rates. A more detailed account of the dispute is reflected in the complaint which is available for inspection at the Commission's office located at Chandler Plaza Building, 1300 S. Evergreen Park Drive S.W., Olympia, Washington and on the Commission's web site at www.wutc.wa.gov/040792. It is appropriate that the matters raised in the pleadings be brought for hearing before the Commission.
- The Commission will hear this matter pursuant to Part IV of chapter 34.05 RCW pertaining to adjudicative proceedings, including but not limited to RCW 34.05.413, RCW 34.05.422, RCW 34.05.431, RCW 34.05.440, RCW 34.05.449, and RCW 34.05.452. The Commission has jurisdiction over this matter pursuant to Title 80 RCW, having legal authority to regulate the rates, services, and practices of water companies providing service within the state of Washington. Statutes and rules cited in the complaint include RCW 80.04.110, RCW 80.04.220, RCW 80.04.230, RCW 80.28.010, RCW 80.28.040, WAC 480-110-255, WAC 480-110-275, WAC 480-110-315, WAC 480-110-365, WAC 480-110-375, and WAC 480-110-385. Statutes involved, in addition to those previously cited, include those within chapters 80.01 RCW, 80.04 RCW, 80.28 RCW, 480-07 WAC, and 480-110 WAC,

- Petitions to intervene should be made in writing at least three business days prior to the date scheduled for the prehearing conference, as required in WAC 480-07-355(a). The Commission will consider petitions to intervene made orally during the conference, but strongly prefers written petitions to intervene. In addition, party representatives must file notices of appearance with the Commission, as required by WAC 480-07-345(2), no later than the day prior to the conference. If any party or witness needs an interpreter or other assistance, please fill out the form attached to this notice and return it to the Commission. The time and place for any evidentiary hearings will be set at the prehearing conference, on the record of a later conference or hearing session, or by later written notice.

THE COMMISSION GIVES NOTICE that any party who fails to attend or participate in the prehearing conference set by this Notice, or any other stage of this proceeding, may be held in default in accordance with RCW 34.05.440. The parties are further advised that the sanction provisions of WAC 480-07-450 are specifically invoked.
