## TO ALL INTERESTED PERSONS:

The Washington Utilities and Transportation Commission has filed an expedited rulemaking (CR-105) under Docket No. A-060085 to correct a production error in a prior rule adoption in Docket No. A-021178, the financial reporting rules.

In Docket No. A-031232, the Commission previously adopted a provision that exempted telecommunications, gas, electric, and water companies from the requirement to pay regulatory fees on *de minimus* revenue amounts. These regulatory fee provisions were inadvertently omitted during the reorganization of the financial reporting rules in Docket No. A-021178.

This proposal would correct the error by adding Subsection (5) in recently repealed WAC sections 480-120-303, 480-120-304, 480-90-208, 480-100-208, and 480-110-275 to the recently adopted WAC sections 480-120-382, 480-120-385, 480-90-252, 480-100-252, and 480-110-505.
