The purpose of this filing is to reflect the cost to the Company to provide water service. The Company has not had a general rate increase in over ten years. During that time, the cost to provide service has increased substantially. This filing will raise approximately \$89,398 in additional annual revenue if customers use the same quantities of water used in 2005. This represents an increase of approximately 38.6%.
