Wiley and Williams, Kastner & Gibbs PLLC, and pursuant to the Commission's Order Instituting Special Proceeding and Notice of Prehearing Conference dated December 28, 2007, RCW 34.05.443 and WAC 480-07-355, address the Order as follows:

I. BASES OF INTEREST/POSITION OF INTERVENORS

Murrey's, as holder of Certificate G-9, is authorized to collect and transport solid waste in areas throughout Pierce County. Island Disposal, as holder of Certificate G-154, is authorized to collect and transport solid waste in areas throughout Whidbey Island. WCW, as holder of Certificate G-253, is authorized to collect and transport solid waste in areas throughout Clark County. Lynnwood and Eastside Disposal, as holders of Certificate G-12, are authorized to collect and transport solid waste in areas throughout areas of Snohomish and King County, respectively. As such, the aforementioned companies (collectively "Petitioners") have a direct interest in the subject matter raised by the Notice and Order filed by the Commission, particularly with respect to the issue of whether the ongoing operations of the Respondents violate RCW 81.77.040 and WAC 480-70-081.

Petitioners contend that the Staff's belief and allegations regarding
Respondents' ongoing activities, as set forth in Section 5 of its Notice, to the best of
Petitioners' knowledge, are accurate in fact and under law.

As the currently authorized solid waste collection companies in the affected territories, Respondents allege that they have a direct stake in the outcome of any Commission ruling in this matter, and assert that a full, fair and complete record could not be adduced in this proceeding without the active participation of the applicant intervenors.

II. PREHEARING CONFERENCE MOTION

The above proposed intervenors are seeking, and will formally request intervention status at the prehearing conference scheduled in the matter on January 24, 2008, and therefore urge the Administrative Law Judge and the Commission to grant
