- 1 On September 2, 2009, Docket TG-091432 was filed by Ada-Lin Waste Systems, Inc., d/b/a Sunshine Disposal & Recycling, under the provisions of RCW 81.77, for temporary authority to operate certificate TCG-63721.
- 2 The Commission having considered the application and being fully advised in the premises finds that it would be in the public interest to grant the application.

**ORDER**

3 **THE COMMISSION ORDERS** That the application is hereby granted, that upon complying with the laws and rules relating to solid waste collection companies, a certificate be issued to Ada-Lin Waste Systems, Inc., d/b/a Sunshine Disposal & Recycling, authorizing the carrier to operate as a temporary solid waste collection company as follows:

GARBAGE COLLECTION SERVICE in that portion of Spokane County described as follows: Starting at the point where the south line of Section 24, T. 26 N., R. 45 E. extended, intersects the Washington-Idaho State line; thence west on said line to the S.W. corner of Section 23, T. 26 N., R. 45 E.; thence north on the west line of said section projected to the S.E. corner of Section 15, T. 26 N., R. 45 E.; thence west on the south line of said section projected to the S.W. corner of Section 16, T. 26 N., R. 45 E.; thence north on the west line of said section projected to the N.W. corner of Section 28, T. 27 N., R. 45 E.; thence east on the north line of said section projected to the Washington-Idaho State line; thence south on said line to its intersection with the south line of Section 24, T. 26 N., R. 45 E. extended, the place of beginning.

- 4 This temporary certificate will end automatically, by operation of law and without further Commission action, when (1) the Commission enters an order approving withdrawal of Application TG-091431, or (2) the Commission enters an order granting Application

TG-091431. If the Commission denies, dismisses, or grants less than all of Application TG-091431, this temporary certificate will terminate on the last day for seeking judicial review of the Commission decision or, in the event of judicial review, on any later date that the reviewing court may order.

- 5 The Commission further orders that the tariff filed in connection with this application will become effective at 12:01 a.m. on the day following the service date of this order.
- 6 The Commission has delegated authority to the Secretary to enter this Order under RCW80.01.030 and WAC 480-07-905(2)(a).

**NOTICE:** This is an order delegated to the Secretary for decision. In addition to serving you a copy of the decision, the Commission will post on its Internet Web site for at least 14 days a listing of all matters delegated to the Secretary for decision. You may seek Commission review of this decision. You must file a request for Commission review of this order no later than fourteen (14) days after the date the decision is posted on the Commission's Web site.

The Commission will schedule your request for review by issuing a notice of hearing to be held before an administrative law judge. The Commission, at its discretion, may consider your request for review in an adjudicative proceeding under RCW 34.05 Part IV, or in a brief adjudicative proceeding under RCW 34.05.482 through .494. Following hearing, the administrative law judge will enter an initial order. If you wish to seek review of the initial order, you may file a petition for administrative review under RCW 34.05.464, or if the matter is heard in a brief adjudicative proceeding, under RCW 34.05.491.

The Commission will grant a late-filed request for review only on a showing of good cause, including a satisfactory explanation of why the person did not timely file the request. A form for late-filed requests is available on the Commission's Web site.

This notice and review process is pursuant to the provisions of RCW 80.01.030 and WAC 480-07-904(2) and (3), and WAC 480-07-905, as amended effective September 22, 2008.
