- 1 The Washington Utilities and Transportation Commission (Commission) issued permit HG-61028 to Neighbors Moving & Storage of Seattle, LLC, d/b/a Heritage Van Lines, Neighbors Moving & Storage, authorizing the services described in the permit.

- 2 On March 3, 2011, Neighbors Moving & Storage of Seattle, LLC filed with the Commission an application that it is adding the trade names of Heritage Moving, Heritage Moving & Storage, Heritage Relocations, Neighbors Moving, Neighbors Movers, Nice Guy Movers, Nice Guy Moving, and Nice Guy Moving & Storage, and requests the Commission amend its records to reflect the addition of the trade names.

- 3 From the information filed by Neighbors Moving & Storage of Seattle, LLC, the request to add the trade names does not involve a change in the ownership, management or control of operating authority held by Neighbors Moving & Storage of Seattle, LLC.

- 4 **THE COMMISSION ORDERS** That the Commission's records and files be amended to reflect permit HG-61028 is held in the name of Neighbors Moving & Storage of Seattle, LLC, d/b/a Neighbors Moving & Storage, Heritage Van Lines, Heritage Moving, Heritage Moving & Storage, Heritage Relocations, Neighbors Moving, Neighbors Movers, Nice Guy Movers, Nice Guy Moving, Nice Guy Moving & Storage.

- 5 The Commission has delegated authority to the Secretary to enter this Order under RCW 80.01.030 and WAC 480-07-905(1)(b).

NOTICE: This is an order delegated to the Secretary for decision. In addition to serving you a copy of the decision, the Commission will post on its Internet Web site for at least 14 days a listing of all matters delegated to the Secretary for decision. You may seek Commission review of this decision. You must file a request for Commission review of this order no later than fourteen (14) days after the date the decision is posted on the Commission's Web site.

The Commission will schedule your request for review by issuing a notice of hearing to be held before an administrative law judge. The Commission, at its discretion, may consider your request for review in an adjudicative proceeding under RCW 34.05 Part IV, or in a brief adjudicative proceeding under RCW 34.05.482 through .494. Following hearing, the administrative law judge will enter an initial order. If you wish to seek review of the initial order, you may file a petition for administrative review under RCW 34.05.464, or if the matter is heard in a brief adjudicative proceeding, under RCW 34.05.491.

The Commission will grant a late-filed request for review only on a showing of good cause, including a satisfactory explanation of why the person did not timely file the request. A form for late-filed requests is available on the Commission's Web site.

This notice and review process is pursuant to the provisions of RCW 80.01.030 and WAC 480-07-904(2) and (3), and WAC 480-07-905, as amended effective September 22, 2008.
