This filing contains proposed language in Section 2 to introduce Identification and Rating of VoIP-PSTN Traffic. It is important to settle the charges for this traffic as soon as possible after the December 29, 2011 effective date of the FCC's Order 11-161. In addition, given the FCC's settlement of this issue effective December 29, 2011, Frontier views these tariff changes as administrative, because they are specifically permitted by the FCC's Order.

The Company requests permission to file the proposed provisions with less than statutory notice. It is important to settle the charges for this traffic as soon as possible after the December 29, 2011 effective date of the FCC's Order 11-161. In addition, given the FCC's settlement of this issue effective December 29, 2011, Frontier views these tariff changes as administrative, because they are specifically permitted by the FCC's Order. This does not result in any "restriction of any service" to customers.

This filing does not impact customer rates therefore, cost support is not submitted.

Frontier requests an effective date of January 1, 2012 for this tariff filing.
