- 1 The Washington Utilities and Transportation Commission (Commission) issued passenger transportation company certificate C-975 to Shuttle Express, Inc., d/b/a Shuttle Express; Go Shuttle Express; Limos by Shuttle Express, (Shuttle Express), authorizing the services described in the certificate.

- 2 On April 13, 2012, Shuttle Express filed with the Commission a notice that it is adding the trade name of Downtown Airporter and requests the Commission amend its records to reflect the addition of the trade name.

- 3 From the information filed by Shuttle Express, the request to add a trade name does not involve a change in the ownership, management or control of operating authority held by Shuttle Express.

ORDER

THE COMMISSION ORDERS:

- 4 (1) The Commission's records and files be amended to reflect that certificate C-975 is held in the name of Shuttle Express, Inc., d/b/a Shuttle Express; Go Shuttle Express; Limos by Shuttle Express, and Downtown Airporter.

- 5 (2) The tariff and time schedule for Shuttle Express, Inc., d/b/a Shuttle Express; Go Shuttle Express; Limos by Shuttle Express, and Downtown Airporter, filed in connection with this application will become effective at 12:01 a.m. on the day following the service date of this Order.

6 The Commission has delegated authority to the Secretary to enter this Order under RCW 80.01.030 and WAC 480-07-905(6)(b).

NOTICE: This is an order delegated to the Secretary for decision. In addition to serving you a copy of the decision, the Commission will post on its Internet Web site for at least 14 days a listing of all matters delegated to the Secretary for decision. You may seek Commission review of this decision. You must file a request for Commission review of this order no later than fourteen (14) days after the date the decision is posted on the Commission's Web site.

The Commission will schedule your request for review by issuing a notice of hearing to be held before an administrative law judge. The Commission, at its discretion, may consider your request for review in an adjudicative proceeding under RCW 34.05 Part IV, or in a brief adjudicative proceeding under RCW 34.05.482 through .494. Following hearing, the administrative law judge will enter an initial order. If you wish to seek review of the initial order, you may file a petition for administrative review under RCW 34.05.464, or if the matter is heard in a brief adjudicative proceeding, under RCW 34.05.491.

The Commission will grant a late-filed request for review only on a showing of good cause, including a satisfactory explanation of why the person did not timely file the request. A form for late-filed requests is available on the Commission's Web site.

This notice and review process is pursuant to the provisions of RCW 80.01.030 and WAC 480-07-904(2) and (3), and WAC 480-07-905, as amended effective September 22, 2008.
