- On July 13, 2012, the Washington Utilities and Transportation Commission (Commission) issued Penalty Assessment UW-120867 against Parkland Water System, Inc. (Parkland Water) in the amount of \$2,100, alleging a violation of WAC 480-110-505, which requires permitted water companies to file annual reports with the Commission by May 1 each year and pay regulatory fees annually on that date.
- On July 24, 2012, Parkland Water filed with the Commission a request for hearing stating that its report was filed on time and regulatory fees were paid. Parkland Water goes on to say that the Commission later returned its report and check stating that no fees were due and requesting the report be returned when additional information became available.
- Pursuant to RCW 34.05.482 and WAC 480-07-610, the Commission determines that a brief adjudicative proceeding is appropriate for determining whether the alleged violation of WAC 480-110-505 occurred and, if so, whether the penalty should be mitigated.
- THE COMMISSION GIVES NOTICE That it will hold a brief adjudicative proceeding in this matter at 1:30 p.m., on Wednesday, September 5, 2012, in Room 108, First Floor, Richard Hemstad Building, 1300 S. Evergreen Park Drive S.W., Olympia, Washington.
