Dear Mr. Asche:

On November 16, 2012, Bremerton-Kitsap Airporter, Inc. (Company), filed with the Washington Utilities and Transportation Commission (Commission) Special Fuel Surcharge Supplement No. 118 to Tariff No. 10. The Company requests the Commission approve the filing to become effective November 20, 2012, on less than statutory notice.

I must deny your request because the Company did not allow the proper time for processing of a fuel surcharge filing, as required by Order 02 in Docket No. A-042090, paragraph A(1)(b): "The requested effective date is at least three business days after the date the request is filed." The Company may refile in compliance with the requirements at any time.

I note that the Commission previously denied your filing the docket TC-120763 for the same reason. Please see the attached letter dated May 29, 2012.

The Company's current surcharge, published in Supplement No 117, will expire November 19, 2012.

Dear Mr. Asche:

On May 29, 2012, Bremerton-Kitsap Airporter, Inc. (the Company), filed with the Washington Utilities and Transportation Commission (Commission) a special fuel surcharge filing of \$2.25 per one-way passenger, which the Commission assigned Docket TC-120763. The Company requested the Commission make the surcharge effective on May 31, 2012.

As you were previously advised by Staff, the Commission by order (Order 05, issued in Docket A-042090) requires all fuel surcharge filings to allow at least three business days for processing. For this reason, I am unable to approve your proposed fuel surcharge.

You are free to refile your request at any time. In the meantime, the Company's \$2.00 per one-way passenger fuel surcharge that became effective on May 23, 2012, pursuant to Docket TC-120719, will remain in effect until June 22, 2012.
