RE: Washington Utilities and Transportation Commission v. SwiftySwift, LLC d/b/a Spokane Party Bus

Commission Staff's Response to Application for Mitigation of Penalties

Docket TE-130214

Dear Mr. King:

On March 5, 2013, the Washington Utilities and Transportation Commission issued a \$75 Penalty Assessment in Docket TE-130214 against SwiftySwift, LLC d/b/a Spokane Party Bus (Spokane Party Bus) for three violation of WAC 480-30-071, which requires Charter and Excursion companies to file annual safety reports with the Commission by December 31 each year; and WAC 480-30-076, which requires such companies to pay regulatory fees annually on that date. <sup>1</sup>

On March 13, 2013, Spokane Party Bus responded to the commission, requesting mitigation of the penalty. In its Mitigation Request, Spokane Party Bus does not dispute that the violations occurred. The company states, "I knowledge [sic] that the regulatory report and fee's [sic] were an oversight by myself. I received a notice on January 10 [sic] 2013 that they had not been filed and that penalties would start January 7<sup>th</sup> [sic] 2013, three days prior to me receiving the notice. There was no email correspondence or mailing giving any warning of the late charges before January 7<sup>th</sup> [sic] 2013. I do not feel this is a fair practice to mail a late fee assessment the day after the penalties have started being charged..." Spokane Party Bus states it made immediate contact with the commission of its error and resolved it. It questions the commission's ability to assess such a penalty. Spokane Party Bus also states that illegal carriers are operating without regulation and taking away its business, despite contacting the appropriate authorities with information about the illegal activity. It requests consideration of the penalty because of its compliance over the past three year while in business.<sup>2</sup>

It is the company's responsibility to ensure that the regulatory fee is paid and the annual report is filed by the December 31 deadline. On November 15, 2012, the commission mailed 2012 Annual Safety Report forms and 2013 regulatory fee packets to Charter and Excursion companies registered in Washington state. A letter from the commission's Assistant Director for Transportation Safety, David Pratt, instructed these companies to file annual reports and pay regulatory fees by December 31, 2012. The letter stated failure to file the annual report by December 31 would result in a penalty and possible cancellation of the company's permit to operate in Washington. Those companies wishing to request an extension to file the annual report were asked to do so prior to December 31, providing a reason for the requested extension. No extension was requested.<sup>3</sup>

On January 7, 2013, the commission issued a notice to companies that had not yet filed their annual report and paid regulatory fees, informing these companies that they were subject to enforcement action, including the assessment of penalties beginning to accrue on that date. Companies that filed their annual reports and paid regulatory fees after January 7, 2013, but on or before January 18, 2013, are subject to penalties that the commission uses its discretion to mitigate to \$25 per day if the company had not made these filings late in prior years. Companies that were late in prior years are subject to an additional \$25 per day for each year in which they were late up to a total of \$100 per day. For first time late-filers who filed their report after January 18, the commission will mitigate the penalties to 50 percent of the maximum permissible amount. No further mitigation will be granted unless the company provides new information that is unrelated to these factors. Mitigation will not be granted on the basis that a company was unaware a report must be filed.<sup>4</sup>

Spokane Party Bus filed its 2012 annual safety report and paid its 2013 regulatory fee on January 10, 2013. That date is three business days past the January 7, 2013, notice date when penalties began to accrue, resulting in a potential penalty assessment of \$300 (\$100 per day times three days). SwiftySwift, LLC, is a first time late-filer and, therefore, received a mitigated penalty of \$25 per day for three days or \$75. The commission could have begun assessing penalties of \$100 per business day, beginning January 2, which would have made the company responsible for a penalty of \$700.

Staff does not support mitigating the \$75 penalty assessment. The penalty was already administratively mitigated by 75 percent, from \$300 to \$75 and Spokane Party Bus provided no new information related to the factors above. Staff recommends denying the mitigation request.

# NOTICE OF PENALTIES INCURRED AND DUE FOR VIOLATIONS OF LAWS AND RULES

PENALTY ASSESSMENT: TE-130214 PENALTY AMOUNT: \$75

According to the Washington Utilities and Transportation Commission (Commission) records, you have committed violations of two Commission rules: (1) Washington Administrative Code (WAC) 480-30-071, which requires Charter and Excursion companies to file annual safety reports with the Commission by December 31 each year; and (2) WAC 480-30-076, which requires such companies to pay regulatory fees annually on that date. You are classified as a Charter and Excursion company. Commission records show that you did not file an annual safety report or pay annual regulatory fees by December 31, 2012.

Revised Code of Washington (RCW) 81.04.405 authorizes the Commission to assess penalties of \$100 for violations of Commission rules. Each and every such violation shall be a separate and distinct offense and, in the case of a continuing violation, every day's continuance shall be and be deemed to be a separate and distinct violation. The Commission interprets noncompliance with WAC 480-30-071 and WAC 480-30-076 as continuing violations, giving rise to penalties of \$100 for each day a company fails to make each requisite filing after the date on which it was due.

As a result, the Commission hereby notifies you that it has assessed penalties against you in the amount of \$75 on the following basis:

On November 15, 2012, the Commission mailed 2012 Annual Safety Report forms and 2013 Regulatory Fee packets to Charter and Excursion companies registered in Washington state. A letter from the Commission's Assistant Director for Transportation Safety, David Pratt, instructed these companies to file annual reports and pay regulatory fees by December 31, 2012. The letter stated failure to file the annual report by December 31 would result in a penalty and possible cancellation of the company's permit to operate in Washington. Those companies wishing to request an extension to file the annual report were asked to do so prior to December 31, providing a reason for the requested extension. No extension was requested.

On January 7, 2013, the Commission issued a notice to companies that had not yet filed their annual report and paid regulatory fees, informing these companies that they were subject to enforcement action, including the assessment of penaltics beginning to accrue on that date. Companies that filed their annual reports and paid regulatory fees after January 7, 2013, but on or before January 18, 2013, are

subject to penalties that the Commission uses its discretion to mitigate to \$25 per day if the company had not made these filings late in prior years. Companies that were late in prior years are subject to an additional \$25 per day for each year in which they were late up to a total of \$100 per day. For first time late-filers who filed their report after January 18, the Commission will mitigate the penalties to 50 percent of the maximum permissible amount. No further mitigation will be granted unless the company provides new information that is unrelated to these factors. Mitigation will not be granted on the basis that a company was unaware a report must be filed.

SwiftySwift, LLC, filed its 2012 Annual Safety Report and paid its 2013 Regulatory Fee on January 10, 2013. That date is three business days past the January 7, 2013, notice date when penalties began to accrue, resulting in a potential penalty assessment of \$300 (\$100 per day times three days). SwiftySwift, LLC, is a first time late-filer and, therefore, is subject to a mitigated penalty of \$25 per day for three days for a total penalty assessment of \$75.

Your penalty is due and payable now. If you believe the violation did not occur, you may request a hearing to contest the penalty assessment. If there is a reason for the violation that you believe should excuse you from the penalty, you may ask for mitigation (reduction) of this penalty. See RCW 81.04.405.

You have the right to present your request for review or mitigation at a hearing, but you are not required to do so. If you do, the Commission will review the evidence supporting your request in an informal hearing, called a Brief Adjudicative Proceeding, before an administrative law judge. The administrative law judge will consider your plea and notify you of his or her decision.

#### You must act within 15 days after receiving this notice to do one of the following:

- · Pay the amount due;
- Request a hearing to contest the occurrence of the violations; or
- Request mitigation to contest the amount of the penalty.

Please indicate your selection on the enclosed form and send it to the Washington Utilities and Transportation Commission, Post Office Box 47250, Olympia, Washington 98504-7250, within FIFTEEN (15) days after you receive this notice.

If you do not act within 15 days, the Commission may refer this matter to the Office of the Attorney General for collection. The Commission will then sue you to collect the penalty.

I knowledge that the regulatory report and fee's were an oversight by myself. I received a notice on January 10 2013 that they had not been filed and that penalties would start January 7th 2013, three days prior to me receiving the notice. There was no email correspondence or mailings giving any warning of the late charges before January 7th 2013. I do not feel this is a fair practice to mail a late fee assessment the day after the penalties have started being charged.

I made immediate contact with the UTC of my error and resolved it immediately that day. I went thru the paper work that was sent, filled out the fees and penalty fee section of the report. Neither the papers sent nor the RCW 81.70.350 state any additional late fee charges. I read nowhere from the RCW or papers about this extremely harmful \$100 or \$25 a day late fee.

I have been in business for 3 years and have never avoided any laws or requirements from the UTC, State, City, or Federal laws regulating my business. I have made numerous complaints to the UTC and Spokane Police enforcement about illegal operations here in the Spokane County and to no resolution. I'm doing my best to see a positive in all this, but I'm on the verge of closing my business because of illegal operators. I have made complaints both to the UTC and local enforcement, only to be told we are under staffed and under budget to properly investigate, but if we catch them we will surly take care of this matter. I have taken pictures and watched as these companies drive by enforcement with no attempt to check their legal status.

I compete with 3 buses and at least 4 stretched limo's that should be registered with the UTC, City, and Federal and be monitored under the same laws that I must operate by. Unfortunately this is not the case, as my buses sit; these companies are under cutting my prices and get my potential customers with lower prices. There is NO enforcement to these companies, NO safety inspections, NO driver checks, NO insurance, NO business licenses, and NO one with the time to put a STOP to this and keep the public safe.

I'm a very frustrated operator, I know this has nothing to do with the subject at hand, but it certainly questions why I go thru all this when in 3 years its clear there is NO one going to take the time to enforce the laws until something terrible occurs, like the little girl in Portland that fell from a bus window and killed. I for one would be devastated if this occurred with my buses because of poor safety checks. I'm thankful the requirements I'm forced to take by the commission to not only protect me but to protect the passengers and other citizens. I just ask that someone please take the time to show those of us that are legal some kind of respect and enforce the same laws to other operators.

Subject: Your Charter and Excursion Annual Safety Report and Regulatory Fees are Due December 31, 2012

You are required to file an annual safety report and pay regulatory fees if you operate as a charter or excursion company.

#### What is required?

By December 31, you must:

- · Complete and file the enclosed 2012 annual safety report form.
- Pay your 2013 regulatory fees.

If you are using U.S. postal mail to send your annual safety report and pay your regulatory fee, the envelope must be postmarked by Monday, December 31, 2012. If you are planning on using another delivery method, the company must ensure that it arrives at the commission by 5:00 p.m. Monday, December 31, 2012.

Pailure to file or mail your annual safety report or pay regulatory fees by December 31, 2012 will result in a penalty and possible cancellation of your permit to operate in Washington. This is the only notice you will receive from the commission.

# What happens if you do not pay your regulatory fees by December 31?

If regulatory fees are not paid by December 31, you will incur:

- · a 2 percent penalty on the amount due; and
- · a 1 percent monthly interest charge on the unpaid balance.

# Can you request an extension of time if you are unable to file the annual safety report by December 31?

Yes, you must provide the request in writing, including a valid reason for the extension by December 31. We will notify you when your request is approved or denied. You will still be liable for penalty and interest payments if you fail to pay your regulatory fees by December 31. If you are late filing your annual safety report or fail to file, you could incur additional penalties up to \$100 a day.

May you perform some of these tasks online?

Yes. You may complete the following tasks from the annual reports page at the UTC website www.utc.wa.gov/annualreports:

Obtain electronic versions of annual report forms

Pay regulatory fees

- File your report electronically
- Cancel your permit if your company ceased operations in 2012.

What if you didn't operate during the year?

You must indicate this on the report and regulatory fee sheet that you've had no operations, include the minimum \$25 fee and return both forms to the commission. If you are no longer using your charter or excursion authority and wish to cancel it, go to our website at <a href="https://www.utc.wa.gov">www.utc.wa.gov</a> and locate the, "voluntary permit cancellation form" or call us at (360) 664-1222 and we'll mail you the form.

#### NOTICE OF ENFORCEMENT ACTION

#### Attention!

Your 2012 annual safety report and regulatory fees to the Utilities and Transportation Commission (commission) were due December 31, as required by law. Financial penalties of \$100 per day begin accruing today, January 7. The penalty will increase by \$100 per day for each additional day you fail to comply.

How do you mitigate your penalty?

If the commission receives your report postmarked no later than January 18, commission staff will mitigate your penalty to \$25 per day. Additional penalties of \$25 per day will be added for each year you have filed a delinquent annual safety report in the past five years, up to a maximum of \$100 per day.
