TO ALL INTERESTED PERSONS:

On November 6, 2013, PacifiCorp, d/b/a Pacific Power & Light Company, filed with the Washington Utilities and Transportation Commission (Commission) a Draft Request for Proposals for Market Resources (RFP).

The RFP is required by WAC 480-107. WAC 480-107-015(3)(b) specifies that all interested persons shall be provided a 60-day public comment period on RFPs. Following the comment period the Commission has 30-days to take action with respect to the solicitation for new resources.

Written comments should be filed with the Commission no later than **January 3, 2014**. The Commission requests that comments be provided in electronic format to enhance public access, for ease of providing comments, to reduce the need for paper copies, and to facilitate quotations from the comments, Comments should be in .pdf Adobe Acrobat or in Word 97 or later version. Comments may be submitted via the Commission's Web portal at <u>www.utc.wa.gov/e-filing</u> or by e-mail to the Commission's Records Center at <u>records@utc.wa.gov</u>. - The docket number of this proceeding (UE-132094).
- The commenting party's name.
- The title and date of the comment or comments.
