**NOTICE OF OPPORTUNITY TO SUBMIT WRITTEN COMMENTS  
ON PROPOSED RULE  
(By Monday, June 9, 2014)**

RE: Rulemaking to consider amending WAC 480-75-250, increasing the maximum civil penalty for violations involving gas pipeline operators, Docket PL-140104

TO ALL INTERESTED PERSONS:

This letter informs you of the progress made in this rulemaking docket concerning the possible adoption of proposed revisions to WAC 480-75-250, “Hazardous Liquid Pipeline Companies,” rules governing hazardous liquids pipeline operators to increase the maximum civil penalties for violations of the gas pipeline safety laws and regulations from \$100,000 to \$200,000 per violation, and a maximum penalty for a related series of violations from \$1,000,000 to \$2,000,000. This letter also provides notice of an opportunity to file written comments on the proposed rule amendments and to participate in the formal rule adoption hearing scheduled for 10:30 a.m. on Wednesday, July 2, 2014.

On May 7, 2014, the Washington Utilities and Transportation Commission (Commission) filed a Notice of Proposed Rulemaking (CR-102) with the Office of the Code Reviser. The proposed rule would provide for the enforcement of pipeline safety standards by injunctive and monetary sanctions that are at a minimum, as stringent as those set out at the federal level under the Code of Federal Regulations. State agency participation in the federal pipeline safety program requires the agency to adopt each federal safety standard applicable to intrastate pipelines under its jurisdiction. The Commission has reviewed comments received from stakeholders received to date in this docket and has prepared a proposed rule for review and comment by interested persons. The proposed rule is available for inspection on the Commission’s web page at [www.utc.wa.gov/140104](http://www.utc.wa.gov/140104). proposed rule mailed to you, please contact the Commission's Records Center at (360) 664-1234. The CR-102 filing initiates the final part of the rulemaking process, which includes a written comment period, a public adoption hearing, and a decision by the Commission.
