- On June 3, 2014, the Washington Utilities and Transportation Commission (Commission) issued Penalty Assessment UT-140925 against TSS Digital Services, Inc. (TSS Digital Services) in the amount of \$1,000, alleging a violation of WAC 480-120-382, which requires permitted telecommunications companies to file annual reports with the Commission by May 1 each year and pay regulatory fees annually on that date.
- On June 6, 2014, TSS Digital Services filed with the Commission a request for hearing stating that all of their traffic (circuits) are VOIP and they should not have any regulatory fees, it has been that way in the past years.
- Pursuant to RCW 34.05.482 and WAC 480-07-610, the Commission determines that a brief adjudicative proceeding is appropriate for determining whether the alleged violation of WAC 480-120-382 occurred and, if so, whether the penalty should be mitigated.
