- On June 5, 2014, the Washington Utilities and Transportation Commission (Commission) issued Penalty Assessment TV-140970 against Morgan Transfer, Inc. (Morgan Transfer or company) in the amount of \$100, alleging a violation of WAC 480-15-480, which requires permitted household goods carrier companies to file annual reports with the Commission by May 1 each year and pay regulatory fees annually on that date.
- On June 17, 2017, Morgan Transfer, Inc. filed with the Commission a request for hearing stating that its report was filed on time. Morgan Transfer goes on to say that the report was mailed and postmarked April 29th or 30th and placed in the downtown Olympia mail along with all other quarterly tax reports. The company claims that none of their other reports were late and asks that the Commission please review the postmark on the report.
- Pursuant to RCW 34.05.482 and WAC 480-07-610, the Commission determines that a brief adjudicative proceeding is appropriate for determining whether the alleged violation of WAC 480-110-505 occurred and, if so, whether the penalty should be mitigated.
- THE COMMISSION GIVES NOTICE That it will hold a brief adjudicative proceeding in this matter at 9:30 a.m., on Tuesday, August 26, 2014, in Room 206, Second Floor, Richard Hemstad Building, 1300 S. Evergreen Park Drive S.W., Olympia, Washington.
