- On June 6, 2014, the Washington Utilities and Transportation Commission (Commission) issued Penalty Assessment tv-140988 against Seattle Select Moving LLC (Seattle Select Moving) in the amount of \$1,000, alleging a violation of WAC 480-15-480, which requires permitted household goods carrier companies to file annual reports with the Commission by May 1 each year and pay regulatory fees annually on that date.
- On June 16, 2014, Seattle Select Moving filed with the Commission a request for hearing stating that their failure to comply with filling an annual report was completely unintentional. Seattle Select Moving goes on to say that they were granted a temporary permit in December 2013, had only performed 6 jobs before the end of the year and that they believe the penalty far outweighs the mistake on their part.
- Pursuant to RCW 34.05.482 and WAC 480-07-610, the Commission determines that a brief adjudicative proceeding is appropriate for determining whether the alleged violation of WAC 480-15-480 occurred and, if so, whether the penalty should be mitigated.
- THE COMMISSION GIVES NOTICE That it will hold a brief adjudicative proceeding in this matter at 9:30 a.m., on Tuesday, August 26, 2014, in Room 206, Second Floor, Richard Hemstad Building, 1300 S. Evergreen Park Drive S.W., Olympia, Washington.

The record in this case will consist of any documents regarding the matter that are considered by or prepared for the presiding officer for the brief adjudicative proceeding and a transcript of any oral statements given at the hearing, which statements will be given under oath.
