- On June 6, 2014, the Washington Utilities and Transportation Commission (Commission) issued Penalty Assessment TV-140988 against Richard D. Worrell (Mr. Worrell) in the amount of \$200, alleging a violation of WAC 480-15-480, which requires permitted household goods carrier companies to file annual reports with the Commission by May 1 each year and pay regulatory fees annually on that date.
- On June 20, 2014, Mr. Worrell filed with the Commission a request for hearing stating that he had submitted his annual report and paid regulatory fees on time, but that he made a mistake and his report was missing his annual mileage.
- Pursuant to RCW 34.05.482 and WAC 480-07-610, the Commission determines that a brief adjudicative proceeding is appropriate for determining whether the alleged violation of WAC 480-15-480 occurred and, if so, whether the penalty should be mitigated.
