- On May 22, 2014, the Washington Utilities and Transportation Commission (Commission) issued Penalty Assessment TG-141013 against Alton L. Montgomery in the amount of \$1,000, alleging a violation of WAC 480-70-071, which requires permitted solid waste companies to file annual reports with the Commission by May 1 each year and pay regulatory fees annually on that date.
- 2 On June 2, 2014, Alton L. Montgomery filed with the Commission a request for hearing stating that its report was filed on time. Mr. Montgomery goes on to say that he was unaware his annual report was filed incompletely until he received a penalty assessment notice from the Commission in the mail.
