- On May 27, 2014, the Washington Utilities and Transportation Commission (Commission) issued Penalty Assessment TE-141056 against Caring Hands Transportation LLC (Caring Hands) in the amount of \$1,000, alleging a violation of WAC 480-30-071, which requires permitted charter and excursion carrier companies to file annual reports with the Commission by May 1 each year and pay regulatory fees annually on that date.
- 2 On June 10, 2014, Caring Hands filed with the Commission a request for hearing stating that they set it aside to do and forgot about it until they received the penalty assessment notice.
