- On May 27, 2014, the Washington Utilities and Transportation Commission (Commission) issued Penalty Assessment TE-141075 against Terry Lee Roberson d/b/a All Adventures Charter Service (Terry Lee Roberson or Company) in the amount of \$1,000, alleging a violation of WAC 480-30-071, which requires permitted charter and excursion carriers to file annual reports with the Commission by May 1 each year and pay regulatory fees annually on that date.
- On June 4, 2014, Terry Lee Roberson filed with the Commission a request for hearing stating that the report was filed on time. Terry Lee Roberson goes on to say that the company was given the wrong e-mail address by Commission staff to submit their report and was unaware the report had not gotten to its proper destination until they later received a penalty notice in the mail.
- Pursuant to RCW 34.05.482 and WAC 480-07-610, the Commission determines that a brief adjudicative proceeding is appropriate for determining whether the alleged violation of WAC 480-30-071 occurred and, if so, whether the penalty should be mitigated.
- THE COMMISSION GIVES NOTICE That it will hold a brief adjudicative proceeding in this matter at 9:30 a.m., on Tuesday, August 26, 2014, in Room 206, Second Floor, Richard Hemstad Building, 1300 S. Evergreen Park Drive S.W., Olympia, Washington.
