Notice of Deficient Application

On December 8, 2015, and January 6, 2016, the Washington Utilities and Transportation Commission sent you a letter to complete or correct the below information in order to process your application for operating authority. To date, we have not received the requested information.

- **Incomplete Application**
 - On page 5 of your application, you indicate "construction and demolition debris and/or recycling materials." This application should be specific to hauling solid waste materials. We need to know where the waste will be taken and disposed. Also, when you state "recycling materials", is this for commercial customers or residential customers? Please explain.
 - Provide a copy of the company's Solid Waste Facility Permit from Snohomish County, #SW-132.
 - Provide a map of the territory you are seeking which describes the boundaries, such as streets, avenues, roads, highways, townships, ranges, city limits, county boundaries or other geographic description, as required by WAC 480-70-091(3)(a). A generic map of King and Snohomish County is not acceptable.
 - On the final page of the application titled Operational Responsibilities, under Tariff Rates and Charges, you indicated "Not Applicable". As noted earlier, a tariff is required. You will need to supplement this application page by providing a name and position to correspond with this responsibility.
- **Financial Information:**
 - Provide Profit-Loss statement for the activity specified in the application-specifically, solid waste hauling.
 - Revenue should be calculated on the number of hauls or customers, and that estimate should be disclosed.

- Expenses should include all the costs associated with the activity including, but not limited to, driver payroll, truck operating and maintenance costs, facility overhead, managerial overhead, fees, licenses, taxes, etc.
 - Include an estimate of depreciation expense associated with solid waste activity, and the method used to allocate depreciation and other overhead; for example, driver hours, truck hours, etc.
 - Revenue and expenses should include any pass-through disposal amounts.
- Rates and Tariffs – You must provide a copy of your proposed tariff as required by WAC 480-70-226 through 351; instructions enclosed.
 - In addition, the following was identified following our December 8 letter:
 - Your business license shows Bobby Wolford Trucking and Salvage, Inc., and, a registered trade name of Bobby Wolford Trucking & Demolition, Inc.

As a corporation, you need to remove the "Inc." from the trade name. Your trade name is another term for "doing business as". Please note that the name is registered correctly with the Department of Revenue (Entity name, Bobby Wolford Trucking and Salvage, Inc.; Business name, Bobby Wolford Trucking & Demolition). Please contact Business Licensing Services at 1-800-451-7985 or www.bls.dor.wa.gov to remove the "Inc." from your trade name.
