COMMERCIAL CAN RATE AND SERVICE CHANGE NOTIFICATION

Dear Customer:

October 10, 2017

As you know, beginning March 1, 2017 we provided customers with wheeled garbage carts to replace manually serviced customer provided cans. Customers received their wheeled carts between March and June 2017. Upon receipt of the carts, customers began to experience a higher rate, which was the result of a request for approval of this new program with the Washington Utilities and Transportation Commission (WUTC) to recover the capital investment, and other costs required for this new program. Unfortunately we recently found there was a mathematical error in the calculation of the new cart rates and we are not currently recovering the cost of this new program.

We worked with the WUTC to correct this mathematical error, and customers will see these new rates on their bills effective November 1, 2017. The new monthly rates are as follows:
