**Present provisions are:**

Tariff No. 16, 6<sup>th</sup> revision, Page 34 Item 230 disposal fees for drop box disposal service at Royal Heights Transfer Site, Raymond, WA is \$106.87 per ton. Current charges for wood waste at Pacific Solid Waste Disposal, Inc. is \$55.00 per ton.

**Proposed changes are:**

Peninsula Sanitation Service, Inc. proposes revising Tariff No. 16, 7<sup>th</sup> Revision, Page 34, Item 230 for drop box disposal service to become effective on less-than-statutory notice on August 1, 2018. The per ton rate in notice from Royal Heights Transfer Station, Inc. has increased from \$106.87 per ton to \$108.81 per ton. The per ton charge for Wood Waste at Pacific Solid Waste Disposal, Inc. has increased from \$55.00 per yard to \$70.00 per yard. Peninsula Sanitation Service, Inc. serves approximately 3,000 customers in Pacific County of which only two commercial compactor drop box customers are affected by the increase at Royal Heights Transfer Station. Peninsula Sanitation Service, Inc. transports a de minimis amount of wood waste annually (less than 74 tons annually). A copy of the notice from Royal Heights Transfer Station, Inc. and a copy of the Transfer Site Charges is attached to this LSN.

Indicate below, or attach, an explanation of the reason the company requests permission to file and publish the proposed provisions with less than statutory notice. The proposed effective date of the disposal fee increase is August 1, 2018.

This LSN is requested as the result of the company's professional advisor having workload constraints which prevented earlier filing. The two disposal sites were late in providing notice of rate increases.
