Dear Mr. Johnson:

Attached please find the updated Work Plan for Puget Sound Energy's ("PSE's") 2019 Integrated Resource Plan ("IRP"). Updates are provided for Appendix A: Work Plan Schedule, Appendix B: IRPAG Charter, and Appendix C: TAG Charter.

Public participation in PSE's 2019 IRP is underway. PSE hosted the first IRP Advisory Group ("IRPAG") meeting on May 30, 2018. The second IRPAG meeting was held the evening of August 28, 2018 as a response to stakeholder's request for evening meetings. All IRPAG meetings in this cycle will be held in the evenings to provide maximum opportunity for public participation. As outlined in the initial Work Plan Schedule provided on July 13, 2018 and updated herein, PSE plans to host a series of Technical Advisory Group ("TAG") meetings in addition to IRPAG meetings during this IRP cycle. The IRPAG meetings are designed to facilitate the public sharing information with PSE. The TAG meetings, scheduled during normal working hours, will provide an opportunity for engagement with industry experts. Everyone is invited to attend IRPAG and TAG meetings. The first TAG meeting was held on July 26, 2018 and the second on October 11, 2018. Five additional meetings have been scheduled. As a response to stakeholder requests, a public IRP comment period has been added to all IRP meetings, commencing with the August 28 IRPAG meeting. PSE looks forward to continuing a robust public participation process that enhances transparency and provides the details necessary to develop a well-supported IRP. PSE will file the final IRP by July 15, 2019.

IRPAG and TAG Charters were finalized in September and are provided herein as updates to the Draft Charters as Appendix B and C, respectively.
