For an Order Approving a Contract for the Sale of Renewable Energy Credits in Accordance with RCW 19.29A.090.	APPROVING CONTRACT

BACKGROUND

- 1 On October 16, 2014, the Washington Utilities and Transportation Commission (Commission) entered Order 01 in Docket UE-141505, which determined that Puget Sound Energy (PSE or Company) may file proposed rates, terms, and conditions for the sale of renewable energy credits (RECs) to its non-residential customers for the Commission's approval under RCW 19.29A.090(5), and may designate information within those filings as confidential pursuant to WAC 480-07-160.
- 2 On December 19, 2019, PSE filed with the Commission a request for an order approving a contract for the sale of RECs to a non-residential customer (Customer) in accordance with RCW 19.29A.090(5). PSE requested the contract go into effect on or before February 1, 2020.
- 3 With its request, PSE submitted to the Commission a fully redacted copy of the contract with the Customer for the sale of RECs. A non-redacted version of the contract was also provided to the Commission and designated confidential pursuant to WAC 480-07-160.
- 4 Commission staff (Staff) reviewed the Company's confidential filing and concluded that the contract is appropriate for approval under RCW 19.29A.090(5). Staff has also concluded that the rates, terms, and conditions are reasonable and in the public interest.¹

¹The confidential contracted rate falls between \$1.00 and \$12.00 per REC. In PSE's tariff filing in Docket UE-141505, the Company submitted a cost of service study demonstrating that the \$1.00 minimum rate is sufficient to cover the cost of providing the service. Staff agrees with PSE that the cost of providing this service is less than \$1.00 per REC.

DISCUSSION

5 We agree with Staff’s recommendation and find that PSE’s contract with its Customer is
appropriate for approval under RCW 19.29A.090(5), and that the rates, terms, and
conditions are reasonable and in the public interest.

FINDINGS AND CONCLUSIONS

6 (1) The Commission is an agency of the State of Washington vested by statute with
the authority to regulate rates, regulations, practices, accounts, securities, transfers
of property, and affiliated interests of public service companies, including electric
companies.

7 (2) PSE is an electric company and a public service company subject to Commission
jurisdiction.

8 (3) On December 19, 2019, PSE filed with the Commission a contract with a
non-residential customer for the sale of RECs pursuant to RCW
19.285.090(5).

9 (4) This matter came before the Commission at its open meeting on January 9, 2020.

10 (5) The Commission finds that the contract is appropriate for approval under RCW
19.29A.090(5), and that the contracted rates, terms, and conditions are reasonable
and are in the public interest.

ORDER

11 **THE COMMISSION ORDERS** That the contract between Puget Sound Energy and its
non-residential customer for the sale of renewable energy credits filed on December 19,
2019, is approved and effective on February 1, 2020.

The Commissioners, having determined this Order to be consistent with the public
interest, directed the Secretary to enter this Order.
