IMPORTANT NOTICE FOR PUGET SOUND ENERGY CUSTOMERS ABOUT PROPOSED CHANGES IN ELECTRIC AND NATURAL GAS RATES

Puget Sound Energy (PSE) recently filed requests with the state Utilities and Transportation Commission (UTC) to adjust electric and natural gas rates. The requested changes, proposed to be effective on May 1, 2020, include:

- Conservation Program Charge (as listed on bill): An overall increase in electric rates of 0.88% and an overall increase in natural gas rates of 0.36% to offset the costs of investments made in energy efficiency programs that are made available to customers
- Property Tax Adjustment: An overall decrease in electric rates of 0.04% and an overall decrease in natural gas rates of
 0.30% to pass through costs of PSE's property tax charges. The proposed changes would be reflected in the Electricity
 charge listed on the electric bill and in the Delivery charge listed on the natural gas bill.
- Revenue Decoupling Adjustment: An overall increase in electric rates of 0.22% and an overall decrease in natural gas
 rates of 0.50% under the decoupling mechanism previously approved by the UTC. The mechanism which allows PSE to
 periodically adjust rates up or down based on differences between actual and allowed revenue from the past year. The
 proposed changes would be reflected in the Electricity charge listed on the electric bill and in the Delivery charge listed on the
 natural gas bill.

Temporary one-year rate adjustments approved last year by the UTC will expire on April 30, 2020 and adjust the following rates on May 1, 2020:

- Cost of Gas (as listed on bill): Expiration of a surcharge will decrease gas rates by 5.46% overall. The temporary surcharge
 trued-up the difference between prior years' projected costs of natural gas in the wholesale market and the actual costs. PSE
 is not allowed to profit on the natural gas it purchases for customers.
- Federal Tax Reform Credit: Expiration of a credit will increase electric rates by 1.12% overall and increase gas rates by
 1.07% overall. The temporary credit finalizes the return of taxes previously collected in 2018. The changes will be reflected in
 the Electricity charge listed on the electric bill and in the Delivery charge listed on the natural gas bill.

The overall average changes for electric and natural gas customers are as follows:

Some electric customers are billed every other month. During the UTC's consideration of these proposed rates, other rates may change due to pending or previously approved rate filings.

The UTC will review each filing and has the authority to set final rates that may vary from PSE's requests, either higher or lower or structured differently, depending on the results of its review.
