GRANTING PETITION TO MODIFY
ACTIVE WARNING DEVICES AT A
PUBLIC HIGHWAY-RAIL GRADE
CROSSING AT STATE ROUTE 124
AND AUTHORIZING EXPENDITURE
FROM THE GRADE CROSSING
PROTECTIVE FUND

USDOT: 808621G

BACKGROUND

- 1 On April 22, 2020, CWW LLC (CWW or Petitioner) filed with the Washington Utilities and Transportation Commission (Commission) a petition seeking approval to modify active warning devices at a highway-rail grade crossing, identified as USDOT 808621G (Petition). The crossing is located at the intersection of State Route 124 (SR-124) and the Petitioner's tracks in Walla Walla County. The Petitioner further requests the Commission authorize an expenditure of \$6,124.02 from the Grade Crossing Protective Fund (GCPF) to pay for the modifications.
- 2 Respondents Washington State Department of Transportation and Port of Columbia consented to entry of an Order by the Commission without further notice or hearing.
- 3 SR-124 is a two-lane roadway with a speed limit of 65 miles per hour. Estimated average annual daily vehicle traffic through the crossing is 1,600 vehicles. SR-124 is part of an established truck route with approximately five percent commercial vehicle traffic. SR-124 is also part of an established school bus route with up to six school buses traveling over the crossing each school day. One freight train operates over this crossing daily at up to 10 miles per hour. No passenger trains operate over the crossing.
- 4 Railroad warning devices at the SR-124 crossing consist of advance warning signs, crossbucks, mast and cantilever-mounted flashing incandescent warning lights, and bells. The Petitioner proposes to replace all of the existing incandescent lights located on the signal masts and cantilevers with new LED lights. These upgrades will improve safety at the crossing by increasing the visibility for roadway users of the crossing. The total cost

of the materials is \$4,624.02. The petitioner also requests \$1,500 to hire a contractor to provide traffic control as required by WSDOT while the work at the crossing is underway. The total amount requested is \$6,124.02. GCPF funds are available for this project. The Petitioner will provide the labor to install the new LED lighting and cover any costs in excess of \$6,124.02.

- 5 Commission staff (Staff) has investigated the Petition and recommends that it be granted subject to the following conditions: (1) expenditure from the GCPF must not exceed \$6,124.02, (2) payment will be made upon presentation of claim for reimbursement for materials and verification by Staff that the work has been satisfactorily completed, (3) the Petitioner signs and returns the attached project agreement, (4) the project must be completed by December 31, 2020, (5) traffic control devices must comply with all applicable standards specified in the U.S. Department of Transportation *Manual on Uniform Traffic Control Devices*, and (6) the Petitioner must notify the Commission within 60 days upon completion of the modifications authorized herein. Acceptance of the changes is subject to inspection by Staff, who will verify that the crossing is in full compliance with applicable laws, regulations, and the conditions specified herein.

DISCUSSION

- 6 RCW 81.53.261 requires that the Commission grant approval prior to modifying a public railroad-highway grade crossing within the state of Washington. RCW 81.53.271 authorizes the Commission to disburse funds from the GCPF to pay for improvements to highway-rail grade crossings. We find that the proposed modifications will improve overall safety for roadway users. Accordingly, the Commission grants the Petition subject to the conditions Staff recommends.

FINDINGS AND CONCLUSIONS

- 7 (1) The Commission is an agency of the state of Washington having jurisdiction over public highway-rail grade crossings within the state of Washington, and authority to approve and administer disbursements from the GCPF.
- 8 (2) The grade crossing at SR-124, identified as USDOT 808621G, is a public highway-rail grade crossing within the state of Washington.
- 9 (3) RCW 81.53.261 requires the Commission to grant approval prior to any changes to public highway-rail grade crossings within the state of Washington.¹

- 10 (4) RCW 81.53.271 allows the Commission to disburse funds from the Grade Crossing Protective Fund to pay for the installation of a grade crossing protective device without requiring the Petitioner to share the cost.
- 11 (5) Commission Staff investigated the Petition and recommends that it be granted subject to the conditions set out in paragraph 5, above.
- 12 (6) After reviewing the Petition filed by CWW on April 22, 2020, and giving due consideration to all relevant matters and for good cause shown, the Commission should grant the Petition and request for disbursement of funds, subject to conditions.

ORDER

THE COMMISSION ORDERS:

- 13 CWW LLC's Petition to upgrade warning devices at highway-rail grade crossing located at SR-124 in Walla Walla County is granted subject to the conditions specified below. The cost of the materials for this upgrade shall be paid from the Grade Crossing Protective Fund. Approval of the Petition is subject to the following conditions:
- (1) Expenditure from the Grade Crossing Protective Fund must not exceed \$6,124.02;
 - (2) Payment will be made upon presentation of claim for reimbursement for materials and verification by Commission Staff that the work has been satisfactorily completed;
 - (3) The Petitioner must sign and return the attached project agreement;
 - (4) The project must be completed no later than December 31, 2020;
 - (5) Traffic control devices must comply with all applicable standards specified in the U.S. Department of Transportation *Manual on Uniform Traffic Control Devices*; and,
 - (6) The Petitioner must notify the Commission within 60 days of the completion of the upgrades authorized in this Order. Acceptance of the upgrades is subject to inspection by Commission Staff, and verification that the crossing is in full compliance with applicable laws, regulations, and the conditions specified in this Order.

The Secretary of the Commission has delegated authority over this matter pursuant to Order 01 in Docket A-180762. The Secretary finds this Order to be consistent with the public interest.
