Dear Chipman Moving & Storage, Inc.:

On September 9, 2020, Chipman Moving & Storage, Inc., d/b/a Chipman Relocations; Chipman Relocation & Logistics, requested that the Washington Utilities and Transportation Commission (Commission) cancel its permit because Chipman Moving & Storage, Inc. is no longer operating.

Based on your request, the Commission **cancels** HG006985. Chipman Moving & Storage, Inc. must **cease** all operations associated with this permit. If you advertise or operate as a household goods mover without a valid permit, the commission may take enforcement action against you.

Please note: You must submit an annual report for that portion of the year in which your company operated. You must also pay the annual regulatory fee if you discontinue operations after the reporting year ends (December 31).
