RATE INCREASE NOTICE FOR COMMERCIAL GARBAGE SERVICE

Dear Customer:

July 30, 2021

Yakima Waste Systems, Inc. has filed a request for a rate increase with the Washington Utilities and Transportation Commission (WUTC) to recover incremental COVID-19 costs incurred between March 2020 and February 2021. The Company incurred additional wages, supplies, and equipment costs due to hazardous working conditions experienced during this time. If this filing is approved by the WUTC, the COVID-19 cost recovery period will be September 1, 2021- August 31, 2023

If approved, the proposed rates below will become effective September 1, 2021. The rate per pick-up will increase as follows:
