DECLARATION OF JASON HOXIT

I, Jason Hoxit, under penalty of perjury under the laws of the state of Washington, declare as follows:

1. I am over 18 years of age and competent to testify to the facts contained herein.
2. I am employed by the Washington Utilities and Transportation Commission (Commission) as a compliance investigator in the Transportation Safety Division. As a compliance investigator, my responsibilities include conducting investigations into the operations of regulated and unregulated transportation companies. As part of those duties, I investigate charter party or excursion service carriers that may be operating without the required Commission-issued certificate.
3. On February 3, 2022, I searched Washington Department of Revenue's Business Licensing Service (DOR), which produced records showing Martin's Gorge Tours, LLC, (Martin's Gorge Tours or Company) in active status in the state of Washington.¹ DOR's records provided UBI: 604-583-723; listed 730 NE Bone Road, Stevenson, Washington, 98648, as both the location and mailing address; and identified Martin Hecht as the governing person.²
4. On February 3, 2022, I searched Washington Secretary of State's (SOS) database, which produced records showing that Martin's Gorge Tours had an active account.³ SOS's records provided UBI: 604-583-723; listed 730 NE Bone Road, Stevenson, Washington, 98648, as both the street and mailing address; and identified Martin Hecht as the governing person.⁴
5. On February 18, 2022, I mailed a compliance letter to Martin's Gorge Tours, which explains that Commission staff (Staff) believes Martin's Gorge Tours is operating as a charter party

or excursion service carrier in the state of Washington without the required certificate. The compliance letter required a written response from the Company by March 4, 2022.⁵

6. On February 25, 2022, Martin's Gorge Tours received the compliance letter at 730 NE Bone Road, Stevenson, Washington, 98648.⁶ The Company never submitted a written response to Staff.
7. On April 26, 2022, I searched Commission records, which showed that Martin's Gorge Tours did not have the required authority to provide charter party or excursion carrier service in the state of Washington.⁷
8. On April 26, 2022, I visited the Company's website, www.martinsgorgetours.com. Under the website's "Book Tour" page, I submitted a reservation request seeking transportation for 10 passengers from the Skamania Lodge in Stevenson, Washington, to various local wineries on June 3, 2022.⁸ After submitting the request, I received a confirmation email from Martin Hecht at reservations@martinsgorgetours.com.⁹
9. On April 26, 2022, I received emails from Martin Hecht at martin@martinsgorgetours.com, in which the Company states it is available to provide transportation for a wine tour on June 3, 2022, provides individual passenger rates of \$130 for the "Standard wine tour" and \$180 for the "Premium tour," and states "[o]ur 14 passenger coach will provide more than adequate safety and comfort for your group of 10+/- guests."¹⁰ Martin's Gorge Tours lists phone numbers (503) 349-1323 and (541) 400-8023 in the email.¹¹
10. On May 5, 2022, I received a text message from phone number (503) 349-1323. In the message, Martin's Gorge Tours inquires if I would like "to further tour arrangements for Friday, 6/3," and informs me that the Company has "had other interest in scheduling this date."¹²
11. On May 20, 2022, I visited the Company's website, www.martinsgorgetours.com. On the homepage, Martin's Gorge Tours advertises "Wine Tours in Oregon & Washington" in addition to tours in the Columbia River Gorge National Scenic Area for "Waterfall & Wildflower, Winery, Brewery & Cider, Guided Hikes, Scenic Drives, [and] Combination

Tours.”¹³ Under the website’s “Shuttle and Charter Services” page, Martin’s Gorge Tours advertises “20 Passenger, 14 Passenger or 6 Passenger Vehicles and Drivers for Shuttle Service and Tours.”¹⁴ On the website’s “Contact Martin’s Gorge Tours” page, the Company provides a picture of a Ford Econoline shuttle bus with license plate number 468-XNY,¹⁵ lists phone number (503) 349-1323, and provides the address of 730 NE Bone Road, Stevenson, Washington, 98648.¹⁶

12. On May 20, 2022, I visited the Company’s Facebook page, www.facebook.com/Martins-Gorge-Tours-104339642952232, which provides the Company’s website of www.martinsgorgetours.com, lists phone number (503) 349-1323, and provides email martin@martinsgorgetours.com.¹⁷ On April 30, 2022, Martin’s Gorge Tours posted the caption “We shuttled this group from Skamania Lodge [in Stevenson, Washington] for their golf retreat at Elk Ridge [in Carson, Washington]” and provided a picture of 20 people.¹⁸
13. On May 20, 2022, I searched Commission records, which showed that Martin’s Gorge Tours does not have the required authority to provide charter party or excursion carrier service in the state of Washington.¹⁹
14. Based on paragraphs 3 through 13 above, Staff finds that Martin’s Gorge Tours is operating as a charter party or excursion service carrier in the state of Washington without first obtaining the required certificate from the Commission.

RE: Charter or Excursion Service Carrier

Dear Martin Hecht:

The Washington Utilities and Transportation Commission (Commission) believes that you are providing passenger transportation services that require charter and excursion authority from the Commission. To advertise, solicit, offer, or enter into an agreement to provide charter or excursion services without a certificate is illegal and subject to a penalty of up to \$5,000 per violation.

The purpose of this letter is to learn more about your passenger transportation services, help you understand charter and excursion regulations, and direct your company to respond to avoid any potential penalties.

What you need to do

To avoid enforcement action by the Commission, your company must:

- Immediately remove any advertisement offering charter or excursion services;
- Stop providing charter or excursion services; and
- Either submit a completed application (enclosed), file proof of insurance, and include the application fee; or respond in writing by March 4, 2022, explaining your company's operations and why they do not require operating authority from the Commission.

Charter and excursion regulations

The Commission regulates charter and excursion carriers in the state of Washington in the public interest.¹

A charter carrier means every person engaged in the transportation of persons for compensation over any public highway in this state who, pursuant to a common purpose and under a single contract, acquire the use of a motor vehicle to travel together as a group to a specified destination or for a particular itinerary, either agreed upon in advance or modified by the chartered group after leaving the place of origin.²

An excursion carrier means every person engaged in the transportation of persons for compensation over any public highway in this state from points of origin within any city, town, or area, to any other location within the state of Washington and returning to that origin. The service must not pick up or drop off passengers after leaving and before returning to the area of origin. The excursions may be regularly scheduled and compensation for the transportation offered or afforded must be computed, charged, or assessed on an individual fare basis.³


In relation to both charter and excursion carriers, a motor vehicle means every self-propelled vehicle with a manufacturer's seating capacity for eight or more passengers, including the driver, used on the public highways for the transportation of persons for compensation.⁴

Application for charter and excursion authority

To provide charter or excursion service, your company must first apply for charter and excursion authority. Your company cannot operate as a charter or excursion carrier in the state of Washington until the Commission grants you a certificate.
