Dear Residential Customer,

This is to notify you of a proposed rate change for residential customers in the Eastside Disposal / Republic Services of Bellevue areas of King County. Should the Washington Utilities and Transportation Commission (Commission) approve our request customers will experience adjustments to all services provided by Eastside Disposal as outlined below.

As you may know, it has been more than a year since our last general rate case. In that time Eastside Disposal has experienced increases in costs that are key to delivering our services, including labor, fuel, and maintenance costs. **If approved, the proposed rates will become effective May 1, 2023.**

The proposed rate increases for our residential services range from -8.2% to 8.5% and not all residential services are listed above. Most customers will likely experience increases of about 7% to 8.5%.
