Enclosed please find the proposed Tariff No. 27 of Fiorito Enterprises, Inc & Rabanco Companies (dba Kent-Meridian Disposal Company, Republic Services of Kent, and Allied Waste Services of Kent), the purpose of which is a general rate increase request. It has been nearly two years since our last general increase on these rates and during that period we have experienced inflationary pressures on key operating costs and made investments in strategic operating assets. The proposed rates will offset increases in labor, fuel, maintenance, healthcare, pension, and other general operating expenses. If approved by the Commission, the overall revenue increase, as reflected in this filing, would be approximately 7.26% or \$1,074,310.

The proposed rates impact services provided as follows:
