Eaton Fiber Washington, LLC ("Eaton Fiber Washington") is filing Attachment A3 to its Registration and Competitive Classification ("Registration") as confidential and unreducted in accordance with Washington Administrative Code ("WAC") 480-07-160(5)(b). Pursuant to this same regulation, Eaton Fiber Washington is also submitting this Attachment A3 in reducted form as public and non-confidential.

As required by WAC 480-07-160(5)(c), Eaton Fiber Washington clearly designated information claimed to be confidential in the unredacted copy by highlighting the text with no more than twenty percent gray shading. Eaton Fiber Washington clearly marked each copy of the unredacted version of the document with the designation, "Shaded information is designated as confidential per WAC 480-07-160" on the first page of a multipage document and on each specific page the provider claims contains confidential information. Additionally, Eaton Fiber Washington has mailed in a sealed envelope a printed copy of the confidential and unredacted Attachment A3 on yellow paper.

Eaton Fiber Washington's claimed confidential information is valuable commercial information in accordance with Revised Code of Washington 80.04.095 and 81.77.210. Specifically, the confidential information includes financial information of subsidiaries of the parent of Eaton Fiber Washington (Tillman FiberCo, LLC and Tillman Infrastructure Holding, LLC), as well of Eaton Fiber Washington's parent company (Eaton Fiber, LLC). The digital infrastructure industry is highly competitive. Thus, such financial information, which includes profits, losses, and the amount of assets and liabilities, as well as the amount of equity in these businesses, represents commercially sensitive and valuable commercial information that cannot be disclosed without harming Eaton Fiber Washington, as well as its parent and subsidiaries of its parent. The release of this information to the general public could competitively disadvantage
