To pass through the required B&O tax increase from 1.75% to 2.1% effective October 1, 2025.

The company is requesting LSN to allow the customers to be noticed on the first bill mailed after the effective date of November 1, 2025, as stated in WAC 480-70-271 (2). Approval of the LSN will save thousands of dollars in printing and postage expense which helps keep rates down for our customers.
