All of the above-mentioned costs have risen substantially since our last general rate increase nearly seven years ago in December 2018. Accordingly, we have applied for a change in rates, subject to the review and approval of the Washington Utilities and Transportation Commission (UTC). These proposed rates are shown on the back of this notice. If approved, the new rates would become effective January 1, 2026.
