NOTICE OF PROPOSED RATE CHANGES FOR CUSTOMERS

Great Basin Water Company LLC has asked the Washington Utilities and Transportation Commission for permission to increase the water rates we charge all our customers. The proposed rates will increase annual revenues to the company by approximately \$108,205 (32%) per year to cover increased operating expenses of labor, insurance, fuel, electricity, etc. If approved, the new rates will be effective on May 1, 2022. The rate increase will be based on water used after April 30th, and reflected on your May 31, 2022 billing.

Below is a table showing the current and proposed water rates flat rate and for $\frac{3}{4}$ meters (cu ft = cubic feet) customers:
