



Re: Replacement Page for UG-220693 - Schedule 215: Adjustment to Rates for Energy Efficiency Service and Programs DO NOT REDOCKET

On September 14, 2022, Northwest Natural Gas Company dba NW Natural (NW Natural or Company) filed Advice No. 22-05, docketed as UG-220693, to reflect adjustments to rates for the effects of applying temporary rate adjustments to forecast and amortize balances for the collection of 2021-22 and 2020-21 program year costs under Schedule G "Energy Efficiency Services and Programs – Residential and Commercial," respectively, After the Company made this filing, an error was found in the tariff page Sheet 215-1 margin coding. This filing corrects the margin coding.

Purpose

The purpose of this filing is to provide a replacement page for Schedule 215. NW Natural inadvertently provided the incorrect margin coding for Sheet 215-1 when filed on September 14, 2022. The enclosed Sheet 215-1 replaces that from the September 14 filing to correct the error.

Proposed Changes

The following verbiage was removed from the tariff but not margin coded correctly as "(D)" for discontinued rate, service, regulation or condition.

"In accordance with Order 06 in Docket UG-200994, half of the Schedule G Historical balance amortization approved in Order 06 in Docket UG-181053 will be suspended for two years beginning November 1, 2021, and a one-year amortization of Conservation potential Assessment (CPA) costs labeled CPA Amortization will begin on November 1, 2021."

The enclosed replacement Sheet 215-1 contains the correct margin codes.

Conclusion

The Company respectfully requests that the replacement tariff sheets filed herewith be approved to become effective with service on and after November 1, 2022.

As required by WAC 480-80-103(4)(a), I certify that I have authority to issue tariff revisions on behalf of NW Natural.
