A Lifeline and ACP customer who wants to receive broadband service for no cost must apply both programs' subsidies and discounts toward, and select, the Unlimited Talk and Text and 16 GB of Data Plan while a Tribal Lifeline and ACP customer will receive the Unlimited Talk, Text, and Data (55 GB of high speed and hotspotting).
