Note 1: Customers will be charged for service requested even if fewer units are picked up on a particular trip. No credit will be given for partially filled cans. No credit will be given if customers fail to set receptacles out for collection.

Note 2: Recycling program charge (in addition to garbage rate) is \$6.01. Additionally, these customers will receive a commodity price adjustment (cpa) of \$2.25**(R) credit per month. Recycle only service is \$7.01 adjusted for cpa.

Note 3: Bi-weekly Yard Waste service is provided at an additional charge of \$5.53 per unit. Special pickup (not requiring dispatch) is \$3.80 per unit.
