4 **Q. Please state your name and business address.**

5 A. My name is Douglas S. Loreen. My business address is 10885 NE Fourth Street,
6 Bellevue, Washington, 98004-5591.

7 **Q. By whom are you employed and in what capacity?**

8 A. I am employed by Puget Sound Energy, Inc. ("PSE") as Director Project
9 Delivery.

10 **Q. What are your duties as Director Project Delivery?**

11 A. As Director Project Delivery, I am responsible for Project Management,
12 Construction Management, and Project Controls for major projects. For the
13 electric system, this includes new and major upgrades to substations, transmission
14 projects, complex distribution beyond the scope of the service provider contract,
15 and interconnections to PSE and third-party generation. For generation, major
16 projects include new plant construction, FERC license projects, and plant
17 additions and betterments of sufficient scope and complexity I am also
18 responsible for the Land Planning group, which provides environmental and land
19 use permitting for all PSE work including major projects.

1 **Q. Briefly describe your education and relevant employment experience.**

2 A. I earned a Bachelor of Science in Electrical Engineering with honors from
3 Washington State University in 1985. Following graduation, I worked for a year
4 at City of Tacoma – Light Division as a Power Supply Engineer. I joined PSE in
5 June 1986, and I have been employed here continuously since that time. My
6 positions at PSE have included Power Resource Engineer, Project Manager-Major
7 Projects, and Manager Electric Resource Planning.

8 Prior to my current position, from October 2007 through May 2011, I was
9 Director Generation Asset Services. In that role I was responsible for providing
10 central technical services to hydro, wind, and natural gas generation fleets.
11 Services included project management, engineering, regulatory compliance,
12 environmental sciences, training and procedures, and budget management. Key
13 major projects included Upper Baker Floating Surface Collector, Lower Baker
14 Adult Fish Trap, and the Upper Baker Fish Hatchery.

15 In June 2011 I took on my current position of Director Project Delivery. As such,
16 I am responsible for implementation of the major capital project portfolio for
17 electric, natural gas, and generation. Key major projects included construction of
18 Lower Snake River Wind Project and the three hydro license implementation
19 projects that are the subjects of my testimony.
