

STATEMENT OF NEW SUBSIDIARY  
PURSUANT TO  
OPUC ORDER 17-526, Stipulated Condition 49 and WUTC Order 01, Stipulated Condition 40<sup>1</sup>

Attached as Exhibit A is an organizational chart for Northwest Natural Holding Company (Holdco), effective as of December 6, 2018.

On October 1, 2018, in connection with the holding company reorganization, Northwest Natural Gas Company (NWN-U) transferred to Holdco all of its subsidiaries other than Northwest Energy Corporation and NWN Gas Reserves LLC, including the following subsidiaries formed or acquired after or around December 28, 2017, the date of the order approving the application for approval of the holding company reorganization.

All of the listed subsidiaries are associated with Holdco's water utility strategy, and none anticipate doing business with NWN-U, except in the ordinary course of business or as set forth in the NWN-U's Master Services Agreement.
