Managing Members of Pacific Northwest Transportation Services, Inc. d/b/a Premier Airport Shuttle / Capital Aeroporter - WUTC Certificate 00862, and Beeline Tours LTD d/b/a Seattle Express - WUTC Certificate 01052, recently made direct communication regarding TC-220090 - Application to Extend Authority of C01052, filed on February 10, 2022, and posted for docket notice on February 15, 2022.
