2) Lauts is a company regulated by the UTC in Washington state. Lauts has been providing collection of commercially generated recyclable materials for nearly 34 years. Lauts owns and operates three material recovery facilities and is currently constructing a fourth. Lautenbach recycling facilities rely heavily on the receipt of collected commodities provided to these recycling facilities by its own collection and transportation division. These facilities also receive materials delivered by generators as well as G-Certificated haulers.

As such, any matters involving the collection, and/or processing of commercially generated construction and demolition and land clearing debris and, commercially generated recyclable industrial materials (organic byproducts), is of great significance to Lauts' operations.

Any adjudication with the potential to set policy for the industry should include representation from the regulated companies.

3) A business such as Lauts is included in the definition of "person" in WAC 480-07-340(1)(a). WAC 480-07-355(1)(a) provides that "any person" may file a Petition to Intervene.

4) Lauts' s participation as an intervenor in this action will not broaden the issues in the matter. At this time, Lauts does not intend to call any witnesses at hearing but reserves the right to do so should issues brought by the primary parties result in the presentation of witnesses by Lauts being helpful to the Commission. Lauts's involvement in this action is necessary to assure it's interests and those of their customers are properly presented and preserved.

5) Lauts's position in this action is expected to be in support of previously established precedents set by the UTC to allow Lauts to further the recycling goals of Washington State.
