TO ALL INTERESTED PERSONS:

This letter is to inform you of the progress made in this rulemaking docket concerning possible adoption of proposed revisions to the rules governing auto transportation company applications and tariffs in Chapter 480-30 WAC. This letter also provides notice of an opportunity to file written comments on the proposed rule amendments and to participate in the formal rule adoption hearing scheduled for Friday, July 26, 2013, at 1:30 p.m.

On September 5, 2012, the Washington Utilities and Transportation Commission (Commission) filed a Preproposal Statement of Inquiry (CR-101) in this docket with the Office of the Code Reviser regarding possible amendments to establish fare setting flexibility and to promote competition between auto transportation companies. The Commission issued draft rules on February 8, 2013, and conducted a workshop on the draft on March 22, 2013. The Commission issued a second set of draft rules on April 12, 2013, along with a notice of opportunity to comment by May 17, 2013, and a small business economic impact statement (SBEIS) questionnaire. The Commission received comments from four stakeholder companies. The Commission filed a Notice of Proposed Rulemaking (CR-102) with the Office of the Code Reviser on June 5, 2013. The CR-102 filing initiates the final part of the rulemaking process, which includes a written comment period, a public adoption hearing, and a decision by the Commission.
