## NOTICE OF DISCUSSION AND VIRTUAL WORKSHOP (Set for Friday, June 3, 2022, at 9:30 a.m.)

Re: In the Matter of the Commission's implementation of participatory funding provisions for regulatory proceedings, Docket U-210595

### TO ALL INTERESTED PERSONS:

On June 23, 2022, the Washington Utilities and Transportation Commission (Commission) will hold a workshop to discuss its implementation of <u>RCW 80.28.430</u>, which provides statutory authority for energy utilities to provide financial assistance to certain organizations participating in regulatory processes before the Commission.

<u>RCW 80.28.430</u> directs the Commission to approve, approve with modifications, or reject proposed funding agreements and directs the Commission and utilities to prioritize funding for organizations that represent vulnerable populations or highly impacted communities.<sup>1</sup> In November 2021, the Commission issued a policy statement detailing its expectations for funding agreements under the new law and stated its intention to continue developing the funding program to ensure it prioritizes highly impacted communities and vulnerable populations.

Based on the guidance provided by the Commission's policy statement, Commission staff (Staff) have developed an implementation plan for the funding program, including implementation of existing funding agreements as well as further research and development to inform future iterations of the program and any additional future policy development. Staff invites interested persons in this docket to a workshop-style discussion on June 3, where Staff will present the Commission's high-level implementation plans for the participatory funding program. Staff invites feedback on those plans during the workshop.

While the workshop will discuss the funding program broadly and generally, it will not discuss specific funding requests currently before the Commission and is not a forum for advancing arguments about specific funding requests.
