RE: Rulemaking to consider rules eliminating the requirement that telecommunications companies file price lists, Chapters 480-80, 480-120, and 480-121 WAC, Docket UT-060676

TO ALL INTERESTED PERSONS:

On October 13, 2006, the Washington Utilities and Transportation Commission (Commission) filed with the Code Reviser a Supplemental Notice of Proposed Rulemaking (Supplemental CR-102) in this docket. The notice set an adoption hearing date of December 14, 2006, to receive oral comments concerning possible adoption of the proposed rules and supplemental proposed rules. Prior to the adoption hearing, Staff notified interested stakeholders via e-mail of new proposed rule language to WAC 480-120-266 regarding the web page requirement.

At the adoption hearing Public Counsel raised concerns regarding the web page requirement in WAC 480-120-266(2), and asked to be allowed additional time to respond to the new proposed language. The Commissioners agreed that the request was reasonable.

Public Counsel may submit written comments on revised proposed rule language to WAC 480-120-266 by filing them with the Commission Secretary either electronically, as described below, or physically delivering your comments to 1300 S.
