TO ALL INTERESTED PERSONS:

On April 22, 2014, the Washington Utilities and Transportation Commission (Commission) filed with the Code Reviser a Preproposal Statement of Inquiry (CR-101) to consider adoption of rules to implement RCW ch. 80.54, relating to attachments to transmission facilities.

The Commission received written comments on its draft rules on October 8, 2014. In addition, Commission staff held a workshop with interested stakeholders on October 28, 2014. As a result of the written comments and the stakeholder workshop, Commission staff has developed revised draft rules for review and comment by interested persons.
